## Membership Rates

Members who are **UK taxpayers** may tick the **Gift Aid** acceptance (opposite) and so increase the value to the Society of their contributions by 20%. **Gift aid** is a means whereby the Society can reclaim the tax that you pay on your subscription and any donations that you may give. There is no maximum or minimum limit on the amount you may give. The only stipulation is that you pay an amount in tax, either Income Tax or Capital Gains Tax, equal to the amount of tax deducted from your donations. The acceptance, once signed, continues indefinitely, but you are entitled to cancel it at any time.

We are able to accept payment by credit card or by cheques in **local currency** from **UK, Australia, New Zealand, Canada** and **USA**. Residents of other countries may pay with one of the above currencies. Please convert the above amounts at the current rate of exchange. **UK** members may pay their subscription by **Direct Debit**, qualifying for a discount on subsequent renewals, by completing the separate Direct Debit form.
